1. Name of the Trust:-

3. <u>Aims</u>:

- (i) The said Trust shall function for Muslim cultural and religious upgrading, work for religious harmony, national integrity, various Educational employment schemes and shall implement the same.
- To work for the upgrading and improvements of the publics especially the minority back-ward community in their education/ Nursery schools/ Educational Institutions from primary to Higher secondary level, job-oriented institutions, Arts and science Colleges,/Professional colleges/ and religious schools and it shall work under the management and supervision of the Trust.
- The Trust has the right to functioning of various institutions to provide job for the un-employed youths, to start cottage industries, and other industries, thereby (iii) eradicate un-employment among the youths.
- (iv) The Trust has the right to functioning of Orphanage(Yatheem Khana), Homes for the homeless, centres to rehabilitate the Handicaps, Hospitals, Nursing schools etc.
 - (v) To start Religious & non religious educational institutions.

(vi) During emergency situations to do relief works, and to give financial aid for treatment/marriage/ construction of houses for the deserving poor people.

(vii) The Trust has the right to start necessary projects/ works, according to decision of the General Body of the Trust, as suited to the life style of people from time

4. Members of the Trust:-

- 1. (a) The number of members of the Trust shall be 101(Hundred and one). Members shall give membership fees/ and any other amount decided by the General Body. If any vacancy occurs in membership, it shall be filled by the Executive Committee as per the decision in General Public Meeting .
- (b) .If any member desires to cease his membership, he can submit an application before the Public Meeting and he can get his membership withdrawn duly approved by the General Meeting.
- 2. In case of death of any Trustee, the said post will be filled by any one member of his family as per the priority i.e. first wife/Husband, then /son/daughter/ and finally grand children. If any one them is a member of the Trust, his or her right will be devolved to the next deserving person.
- 3. If any member has failed to pay his dues even after receiving the Notice issued by the Trust in which notifying him to pay the same within the time limit as stated in the notice, the defaulter can be removed from the membership as per the decision
- 4. Any member who has any dues to be paid, shall be disqualified for contesting in the Executive Committee.

Funds of the Trust.

The source of income of Trust Funds shall be as under :-

By the membership fees given by the members, Donations, amount contributed by well-wishers, amount collected from other sources, amounts received from people in ndia and abroad through recognized sources and means, and income from properties, nstitutions belonged to the Trust and from its business, and aids from Govt and

The capital fund for functioning of the Trust shall be Rs. 10,100/-.(Rupees Ten Thousand and hundred only)

6. Conveners.

- 1. The Trust shall have the following conveners. The official conveners shall be elected by the members of General Body meeting of the Trust. At the time of election, the members who are working outside Kerala shall cast their vote by Proxy.
- 2. This office conveners consists of 15 persons out which 5 persons shall be elected as (1) Chairman (2) Vice Chairman (3) General Secretary, (4) Secretary & (5) Treasurer, and 10 persons shall be elected as committee members, and the said 15 persons shall be known as "Executive Committee".
- 3. For election proceedings, an "election officer" can be appointed if needed, and official tenure of the conveners will be 3 years.
- 4. The Executive Committee has the right to implement new decisions by obtaining prior approval from General Body and to do day to day affairs of the Trust.
- 7. (1). The Trust Fund should be deposited in the Bank in the joint names of Chairman, General Secretary and the Treasurer.
 - (2) For emergency needs, an amount upto Rs. 5,000/-(Five Thousand) shall be kept, under the custody of the Treasurer.

8. Quorum.

The quorum of the General Body meeting of the Trust shall be 25 members. Quorum of Trust executive shall be 8 members. If the 1st meeting is quashed under insufficient quorum, the second meeting shall be held without the sufficient quorum.

9. Official powers and duties of the Executive Committee.

1. Chairman.

(a) Qualifications: He should have minimum education, be efficient, loyal, trustworthy, matured and impartial.

2. Vice-chairman.

- (a) Qualifications: All the qualifications prescribed for chairman is equally applicable to the vice-chairman also.
- (b) Powers and duties. To carry out duties of the Chairman in his absence.

3. General Secretary.

- (a) Qualifications. Qualifications prescribed for chairman and vice chairman is equally applicable to the General secretary also.
- (b) <u>Powers and duties</u>. General Secretary shall represent the Trust. He will be responsible for up-keeping of all records belonging to the Trust. He shall convene the meetings as and when required after issuing notice as per the instructions of the Chairman, prepare minutes and reports and submit the same in the meeting, implement minutes taken in the meeting, write and keep all records of the Trust, to carry out the works sanctioned/approved by the meeting, to conduct litigations and cases pertaining to the Trust.

4. Secretary.

- (a) Qualifications: All the qualifications prescribed for General Secretary shall be applicable to the Secretary also.
- (b) Powers and duties. To carry out the duties of the General secretary in his absence. To help the General secretary in his official duties.

5. Treasurer

(a) Qualifications. He should have all the qualifications prescribed for the Chairman/vice chairman/General Secretary/ and Secretary. Moreover, he should be financially sound and free from any debts, he should have public confidence, efficient in book keeping & accounts

(b) Powers and duties. To keep the accounts of income and expenditure/to issue receipts for the income/ to issue voucher for the expenditure/ to keep list and particulars of each members/to submit income and expenditure statements in the meeting.

(a) Qualifications: Qualifications required for official members shall be applicable

(b) Duties. To help the officials in carrying out their duties. to committee members also.

As per the decisions taken by the General Body meeting of the Trust, the Trust Chairman/Vice chairman,/General Secretary/Secretary/Treasurer/ and 6 Committee 0.Registration: members are appointed for the purpose of registration of this Trust.

 - 4. If any temporary vacancy arises in the Trust Executive Committee, it should be filled
 - 5. (a) Powers to decide the Agenda of the General Body meeting shall be vested with
 - (b) The agenda of Executive Committee shall be decided by the Chairman and
 - (c) If any member desires to discuss any matter /matters related to the Trust in the General Body meeting, inclusion of such matter in the Agenda should be informed in writing to the Secretary before 5 days of the commencement of meeting. (d) If members not less than 25 desire to discuss any matter in the General Body meeting duly written their names and address and signed, such meeting should be called for within 7 days. It is compulsory that 2/3rd of the said members should be present in the meeting.

16. Seven days prior Notice for the General Body meeting and Two days prior Notice for Executive meeting of the Trust should be given and prescribed quorum for each of such meeting is mandatory. Decision taken in the meeting shall be applicable to the members those who were not present.

- 17. General Body meeting of the Trust should be conducted once in 3 months, & Annual General body meeting conducted once in a year, and Report of the meeting and audited accounts and budget for next year should be presented and passed. Executive committee meeting should be conducted once in every month, and on emergency situations it shall be conducted with immediate notice. All the minutes of such meetings should be written and kept on record.
 - 18.Imam of Paipad Muslim Puthen Palli Juma-at shall be a special invitee in the General body meeting of the Trust.
 - 19. For functioning of each institution of the Trust, it shall have its own Bye laws and such bye laws should be made by a Committee appointed by the General body. Necessary amendments can be made if needed in the Bye laws, and the Committee shall function accordingly.
 - 20. For smooth functioning of each institutions of the Trust, there shall be 7 members which include Chairman of the Trust, General Secretary and the Treasurer.
 - 21. For any reasons if this Trust cease to function, General Body meeting shall be called for, and future plans/ and programmes decided/ implemented with 3/4 majority of the members.


